Roosevelt Public Power District will award one \$1000 scholarship from Basin Electric Power Cooperative and two \$500 scholarships from Tri-State Generation and Transmission, Inc. to dependents of local Roosevelt consumers.

The scholarship program, which is in its 29th year, encourages continuing education and serves as an investment in the economic future of rural areas.

Applicants for the scholarships must be U.S. citizens and planning to enroll in a full-time undergraduate or graduate course of study at an accredited two-year or four-year college, university or vocational/technical school.

The Basin \$1000 scholarship recipient will be chosen based on a combination of SAT/ACT scores and overall grade-point average, work experience, participation in school and community activities, a personal statement of career goals and a written recommendation by a third party.

The two Tri-State \$500 scholarship recipients will be chosen based on a personal statement of educational goals and a written recommendation by a third party.

One application will be sufficient for all scholarships.
